RG 8-I-1Pardon and Parole

Box 1

- Folder 1: *Correspondence, 1931-1934.* Includes a proclamation of Washington's Birthday in 1934, a letter recommending a pardon (Jefferson County politics), requests for leaves of absence, reprieves, temporary paroles, paroles, and movement of prisoners. Murray's reactions to occasional editorials about decisions.
 - 2: Paroles, etc. 1931-1934.

Correspondence on paroles, leaves of absence, reprieves, pardons, and clemency. An item deals with the difficulty on the part of a law firm in collecting a fee because payment was attempted by means of the transfer of a deed to property not owned. Also included is a copy of the weekly letter about pardon and parole policy. Other letters explain aspects of the policy, and indicate Murray's personal opinions of the various types of crime. Matthew Kimes becomes an issue when rumors of his parole provoke letters and petitions of protest, forcing Murray to explain his release of Kimes. A misfiled letter deals with allegations that the Federal Emergency Relief Administration (FERA) spent too much money on mules.

RG 8-I-2 Land Office

Folder 1: School Land Commission-1931, 1932, 1933.

Topics include minor rewards for political loyalty, and money problems such as requests for loan repayments extensions and a threat to sue the commission. Additional items are minutes for February 2, 1931, letters of endorsement, a list of loans owed by legislators and former legislators as of December 31, 1932 (with a list of land commissioners under each governor), an audit contract for 1932, material on foreclosure sales, a request for the right to cut wood on school lands, report of the secretary for 1931-1932, report of foreclosures as of December 31, 1932, and a letter from the secretary about a proposal to modify loan terms. The secretary threatened to resign. An executive order authorized the National Guard to bar the land office door to the pretended land office secretary and other persons in 1933. Other items concern the collection of delinquent interest, minutes for October 1933, a 1933 digest of laws concerning tax sales, an analysis of the Homestead Act, and a "statement of facts" by Murray about the situation in the secretary's office in 1933.

Folder 2: School Land Transactions, 1932-1934. The file includes material on questionable loans, a report of an investigative committee, a record of cash and securities transferred from Becketto Carpenter, a report of legal descriptions of farm loan foreclosures, a report of the audit of February 1932, on oil royalties, the charges against Sam Pollard of embezzlement, the colonization of Bolivia, drought relief, timber, re-sales, and more.

RG 8-I-3 Federal Emergency Relief Administration (F.E.R.A.)

- Folder 1: *Rogers County, 1933.* Contains a 1931 application for stay of execution for Paul Cole, charges of irregularities in the Oklahoma Building and Loan Association, project proposals, and payroll records for Roger Mills and Latimer county projects.
 - 2: *Rogers County, 1933.* Payrolls for Latimer and Roger Mills counties.
 - 3: *Pottawatomie County, 1933.* Includes project proposals, quarterly requests for money by the capitol custodian for fiscal year 1934, and a copy of the Rules and Regulations adopted by the Emergency Relief Board, February 7, 1931.

 - 6: *Lake Murray, 1933.* Contents are an affidavit, claim, and itemized statement for making abstracts.

 - 10: Woodward County, 1933.Projects approved and a county map showing locations of projects.
 - 11: *Love County, 1933.* Projects approved and correspondence.

- Folder 2: *Atoka County, 1933.* Requests for projects, employment materials, a resolution for the Wynona city dam, allegations of waste, and projects approved with related correspondence. Projects include Coal (with a profile of the proposed dam), Kingfisher, Okmulgee, and Pontotoc Counties. Items include an easement in Cotton County for Murray Lake, and projects in Texas, Tulsa, Seminole, Hughes, Nowata, and Delaware counties.
 - 3: *Pontotoc County Indians Projects-Special, 1933.* Projects approved for Pontotoc County Indians.
 - 4: Public Lakes Listed, 1933.
 Correspondence and resolutions on Byrd-Mill, Krebs City Lake, Hominy, Welston Lake, the Okmulgee County dam, the LeFlore County dam, Dustin Lake, Gage Lake, and assorted projects in Bristow, Seminole, Drumright, and Beaver. Items include maps, blue prints, a deed, and more.
 - 5-8: Pontotoc County and Stephens County and Texas County and Tillman County, 1933.
 Projects approved.
 - 9: *Tulsa County, 1933.* Correspondence and projects approved. The Tulsa NRA suggests a survey to determine the impact of relief programs on the unemployed.
 - 10: Oklahoma County Soup Kitchen, 1933.Items on supply authorizations and purchases. Includes both the soup kitchen and the State Relief Camp.
 - 11: *Sequoyah County, 1933.* Projects approved.
 - 12: Private Lakes Listed.

Includes a list of lakes by county, a blueprint for Murray Lake and Dam, a deed for public access to a private lake on the condition that the state build and maintain a dam on said lake, and lake projects in Jefferson, Logan, and Muskogee counties. A resolution from Haskell provides right of access in return for a dam. Approvals are from Beaver, Delaware, and Beckham Counties. Correspondence concerns the project at Guymon. Other county projects are in Texas, Jackson, Jefferson, Harper, Greer counties, Fargo, Arnett, Shattuck, and Oklahoma. Tillman County material includes a near complete package on Lake Billie Murray Jr. Hughes and Roger Mills counties also have projects. A final item is a list of charters issued for October 1932.

Folder 13: Carter County, 1933.

Topics include the 1932 Red Cross clothes making project, a boy scout camp, the American Legion, City Beautiful projects in Healdton, Ardmore, and others, a proposed RFC loan to build a Healdton city recreation lake, and 1933 cemetery and other clean-up ideas. Other projects include canning, building a sewing room, and creating a dam. Another letter concerns postage stamps.

- 14: *Pittsburg County, 1933.* Projects approved.
- 14(2): Miscellaneous Projects, 1933.
 Unemployment relief census material from Okfuskee, Pittsburg, Nowata, Delaware, Harmon, Greer, Major, Washington, Osage, and Murray counties.

RG 8-I-4 <u>Miscellaneous</u>

- Folder 1: William H. Murray-Special Messages, Addresses, Speeches, 1934. A telegram from Harry Byrd on the Madison memorial, a telegram to Governor Gifford Pinchot, deficiencies are sought to finance condemnations for Lake Murray, and a court decision requires the state to pay more that it originally offered. Other items are the governor's information letter about modes and methods of work relief, "Speech Delivered by Hon. Melvin Cornish, Chairman, Oklahoma Tax Commission, April 23, 1931," and material about a series of meetings on saving state money, proclamations of Hospital Day, prayer days, the National Congress on Unemployment Relief, additional pages of the Cornish speech, Murray's speech to the constitutional revision committee, and a press release about Murray's decoration day speech in Los Angeles. Additional items concern the declaration of martial law at the Red River Bridge, tax relief, restriction of depositories for public funds, financing of farm-to-market roads, and closing of propagated oil wells. A final item is a copy of "Extemporaneous Remarks by Murray before the legislative session of February 4, 1937."
 - 2: *Claims Filed 155-180, 1933.* Miscellaneous, including rewards with affidavits.
 - 3-12: *Charters Issued, 1931.* Monthly lists, January through October.

Folder 13: *Duties of Secretary's Office, 1928.* Contents are a cover letter for a vetoed bill in July 1933, two copies of a letter from the secretary of state to Governor Johnston about the duties of the secretary of state, and a summary of activities and expenses for the governor's annual message.

- 14: Certified Copy, Lake Elmer Thomas, 1939.
 Includes copies from the secretary of state on material related to Wichita Little Medicine Lake and correspondence.
- 15: *Grady County Election, 1931.*

Materials on the election to move territory from Grady to Stephens county includes a list of voters with notes about unauthorized voters, an affidavit about the comparative distance of the two county seats, minutes of the Grady County election board, a protest against the calling of the election, a list of petitioners for the election, an affidavit about the number of votes cast in the 1934 gubernatorial election in Grady County, township maps with calculations of the numbers of votes and a summary of the calculations, maps of Stephens and Grady counties, the proclamation of election and certification of posting, appointment of election commissioners, and protests and objections.

16-26: Claims Filed, 1-283, 1932.

In order by month and claim number include office expenses, payrolls, rewards, and special investigations.

Other material includes a 1934 deportation letter, 1934 paroles, a 1934 assignment of contract by the fire marshal to pay off a loan, financial matters, a proclamation of Memorial Day, and additional appointments including judges and members of the governor's staff.
 - 8: *Appointments and Commissions, September, 1934.* Appointments of a dental examiner, county commissioners, and members of the governor's staff.
 - 9: *Appointments and Commissions, August 1934.* Appointments are of a textbook commissioner and a large number of colonels on the governor's staff.

Items concern the disqualification of a judge and his replacement, the appointment of Lloyd Noble as regent, an appointment to the textbook commission, a list of regents, endorsement of Noble, appointments of judges county commissioner appointments, and commissions of more colonels.
 - 11-12: Appointments and Commissions, April-June 1934.
 - 13: *Deficiency Certificates Issued by Governor Marland, 1934-1935.* List and copies of certificates.
 - 14: *Appointments and Commissions, April 1934.* Justices and a county commissioner.

 - 6: *Communications to 14th Legislature, June 1933.* Items deal with signed bills, vetoes, suggested legislation, reports to Murray about the Bar Commission Fund, appropriations for the textbook commission, suggestions for the formation of the Oklahoma Rangers, and an oil depletion clause to the income tax bill.
